## BEVERAGE SERVICE

The Vibrant Vine provides all bar services.

The bar can be stocked with your preference of Vibrant Vine wine/sparkling, as well as beer, cider, spirits, and/or non-alcoholic drinks depending on your brand of choice. Bar options include: cash bar, host bar, or toonie/loonie/five dollar bar.

Your rental fee includes one bartender.

Extra bartenders are \$25 per hour (minimum of 2 hours). We recommend one bartender for every 25 people. This service also includes all glassware. There is an automatic 18% gratuity attached to all beverages and beverage services.

The legal drinking age in British Columbia is 19 years of age. Alcohol consumption on

The Vibrant Vine property is limited exclusively to those who have reached this age. Servers/Bartenders reserve the right to refuse service to those who fail to provide Government Issue Identification when asked. Outside alcohol is not permitted, and is subject to a corkage fee.

# Terms & Conditions

All private event agreements are made upon and subject to the current rules and regulations of The Vibrant Vine Winery:

## BOOK A DATE

The Vibrant Vine Winery requires a signed contract and deposit payment to book a date. The deposit required is 100% of the venue rental charge. A change of date forfeits the deposit payment, and an additional deposit is required. Payment can be made by credit card or e-transfer.

## PAYMENTS

The Client shall pay the total price for all wedding services and products in accordance with the payment schedule set out below:

**Upon Booking:** 100% of the venue rental fee is required (non-refundable)

**2-Weeks Prior:** Any extras such as equipment rentals, linens, beverage, staffing costs, taxes and gratuities will be charged.

**Within 24 hours:** Your bar bill and any outstanding incidentals will be charged.

## CANCELLATION

All payments are non-refundable and non-transferable with the exception of a 'Force Majeure' Event.

## SERVICE CHARGE & TAX

All prices are subject to applicable taxes. All food & beverages fees are subject to a gratuity of 18%

Lakeview Room & Terrace – 90 (60 indoors and 30 outdoors)

Maple Avenue – 90

Jacko's Lounge – 50

Your final guest count must be issued to The Vibrant Vine Winery 2 weeks prior to the event day.

## PROPERTY ACCESS

The Rental Agreement only includes your exclusive use of the booked areas. The Vibrant Vine Winery remains open to the public.

## WEATHER

Due to the unpredictability of weather forecasts (Lakeview Room Terrace) we recommend that you have a contingency plan for bad weather. The Vibrant Vine Winery is not responsible for providing an indoor or bad weather back-up option.

## LIQUOR LICENSES

Liquor license hours for our different venues are listed below:

Lakeview Room & Terrace – Licensed Venue Available every day 11am – 11pm

Maple Avenue – 11am – 10pm

Jacko's Lounge – 11am – 11pm

All liquor must be purchased through The Vibrant Vine Winery. No outside alcohol may be brought onto the premises including in the parking lot.

## WINE SELECTIONS

Your wine and beverage selections can be made within 2-weeks of your event day.

## CATERING

The Vibrant Vine Winery does not have in-house catering services, it is the client's responsibility to book a caterer. Please see our list of preferred vendors. Other caterers are permitted on site subject to The Vibrant Vine Winery's approval.

## MUSIC

Music must not exceed 75 decibels and must conclude no later than 10:00pm.



# Terms & Conditions

All private event agreements are made upon and subject to the current rules and regulations of The Vibrant Vine Winery:

## **SET-UP & TEAR DOWN**

All set-up and tear-down (including your vendor set-up) must be completed 30 minutes prior and 30 minutes after your rental period. For additional set-up and tear-down time please speak to our Events Manager. Additional time is subject to an extra charge.

## **DÉCOR**

All décor must be approved by our Events Team prior to the day. No items may be nailed, tacked, taped, or otherwise attached to the structure of the winery.

## **CLEANING**

Please ensure all personal items for the setup and décor associated with your event have been removed. If further cleaning is required, an additional charge will be added to your final bill.

## **CANDLES & SPARKLERS**

Candles and sparklers are not permitted on site.

## **LIABILITY**

The Vibrant Vine Winery is not responsible for actions of any visitors while at the winery for any injuries, harm, lost or stolen goods and damages.

## **EVENT INSURANCE**

The client is responsible for any damages to or on The Vibrant Vine property and/or injury to staff and/or guests caused by the client, their guests, or their vendors. It is recommended that the client obtain event insurance for this.

## **SMOKING**

All guests must adhere to the strict 'no smoking' policy within the winery and grounds. Smoking is only permitted in the dedicated smoking area in the parking lot.

## **PETS**

No animals or pets are permitted on the property.

## **WASHROOMS**

Lakeview Room & Terrace – public washrooms are available  
Jacko's Lounge – public washrooms are available

## **ACCESS TO THE VINEYARD**

No guests are to wander in the vineyards without prior approval.

## **FORCE MAJEURE**

If the Agreement becomes impossible to perform by The Vibrant Vine Winery due to acts of God, war, government regulations, natural disasters including without limitation fires or floods, strikes, civil disorder, extreme weather, pandemics, or any other emergency making it illegal or impossible to provide the facilities or services or otherwise to hold the event (a "Force Majeure Event"), this Agreement may be terminated by The Vibrant Vine Winery by written notice to the Client. Upon the happening of a Force Majeure Event, The Vibrant Vine Winery agrees to use reasonable commercial efforts to work with the Client to reschedule the event date. If The Vibrant Vine Winery and the Client are unable to mutually agree on a rescheduled date, the Initial Deposit shall be forfeit to The Vibrant Vine Winery in exchange for services provided up to the date of the Force Majeure Event.
